County Commissioners Report-Zach was not in attendance, but provided an emailed update to board members which highlighted updates with the Planning Commission, LEAP and ITC

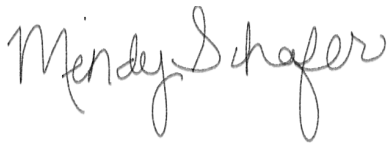
Zoning Administrators Report-No Report
