The old Jaws of Life was sold and the funds will be used toward the new set. The department has responded to many mutual aid calls for fires and downed limbs. There is one potential new hire, which would fill the department at 26 firefighters.

Clerk: Clerk Schafer reported that she is working on year-end and audit preparation and election training and planning.

Treasurer: K. Halfmann reported that the FD Emergency account was closed and the funds transferred to the FD checking account.

Supervisor: V. Feldpausch shared that has begun receiving calls regarding the chloride application schedule. He provided an update on the status of CAASA.
