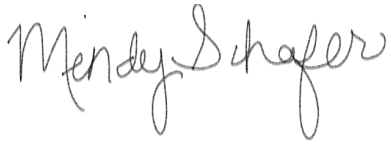
Approval of 2026-2028 Assessor's Contract–Because Supervisor Feldpausch is required to sign the contract, the item was tabled to the March 30 meeting.
