She shared the township was awarded a Sunlight Award for being a Vigilant Steward from the Michigan Fair Elections Institute. This award was received for maintaining accurate voter registration records. Deputy Clerk Koenigsknecht plays a big role in this process.

Treasurer-Treasurer Halfmann asked a couple of clarifying questions on how the ambulance assessment should appear on tax bills for multi-unit properties. She presented the winter newsletter for the board to proofread.

Supervisor-Supervisor Feldpausch reported working on land divisions and that the private cemetery inquiry is currently in a holding pattern. Gerry Arens has agreed to serve on the Board of Review. Once approved by the board, he will be sworn in prior to their next meeting.

County Commissioners Report-Zach was not in attendance, but provided an emailed update to board members

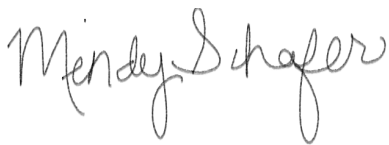
Zoning Administrators Report-Tammy provided the board with a summary of zoning activity.
